2. The County EMS Fly car system continues to be busy with 316 call in the month of February 2025.
3. Commissioner Schulte and I had a 6-month meeting with Seniorcare EMS to review operations and explore ways to make improvements where possible. Seniorcare is no doubt committed to the success in our EMS system.

WHEREAS, the Sullivan County Jail and Corrections Officers have for decades provided for the care and custody of persons awaiting trial, convicts, and others, but has in recent years experienced significant staff shortages which strain the facility’s remaining workforce, who nonetheless diligently and commendably endeavor to maintain the safe and secure operation of the Correctional Facility and thereby protect and serve the public, and

WHEREAS, in a time when local governments, including Sullivan County, are grappling with severe staffing shortages and the need for qualified, experienced personnel, Governor Hochul’s executive order only exacerbates the crisis, and

WHEREAS, it is unthinkable and outrageous that in the same breath, that she push for second changes through the Clean State Act, she is denying those who have devoted their careers to public service the chance to continue their work and support their families.

NOW, THEREFORE, BE IT RESOLVED, that the Sullivan County Legislature hereby strongly opposes Governor Hochul’s Executive Order No. 47.3 and urge her to reconsider this ill-conceived order and

RESOLUTION INTRODUCED BY THE PUBLIC SAFETY AND LAW ENFORCEMENT COMMITTEE TO AUTHORIZE AND FUND PHASE I OF THE GOVERNMENT CENTER CRITICAL INFRASTRUCTURE SECURITY IMPROVEMENT PLAN

WHEREAS, in light of national and global trends in targeted violence, it is imperative to enhance the safety and security of the Sullivan County Government Center to protect employees, visitors, and the general public; and

WHEREAS, improving security measures at the Government Center will also enhance the overall customer experience by ensuring a safe and welcoming environment for all who enter; and

WHEREAS, the Sullivan County Division of Public Safety has developed Phase I of the Government Center Critical Infrastructure Security Improvement Plan to address these concerns through targeted staffing and technological enhancements; and

WHEREAS, Phase I of this plan includes the following key components:

- The creation of two (2) new Corrections Deputy positions within the Sheriff’s Office to increase on-site law enforcement staffing for enhanced security screening and customer service;
- The creation of one (1) Building Safety Monitor position to provide civilian visitor-greeting, way-finding, and general assistance;
- The purchase of a weapons detection system and lease of associated software support and services to facilitate the screening of all employees, visitors, and their baggage; and

WHEREAS, salaries for these new positions shall be set in accordance with existing salary schedules and/or collective bargaining agreements; and

WHEREAS, the total cost of Phase I of the Government Center Critical Infrastructure Security Improvement Plan is \$417,386.56, with the following breakdown:

- Salary for two (2) new Corrections Deputy positions - \$111,358.00
- Benefits for two (2) new Corrections Deputy positions - \$78,516.17
- Salary for one (1) Building Safety Monitor - \$42,383.00

- Benefits for one (1) Building Safety Monitor - \$36,204.00
- Purchase of Weapons Detection System (Hardware) - \$94,456.26
- Software and Services (year 1) - \$17,498.80, (years 2-4, annual cost) - \$13,304.14; and

WHEREAS, legislative approval and funding are required to ensure the immediate implementation of these security enhancements;

NOW, THEREFORE, BE IT RESOLVED, that the Sullivan County Public Safety and Law Enforcement Committee hereby approves and authorizes funding in the amount of \$417,386.56 for the implementation of Phase I of the Government Center Critical Infrastructure Security Improvement Plan, effective immediately upon final ratification by the full Legislative Board; and
