- ❖ 2026 General Election: November 3, 2026
- ❖ 2026 Primary Election: June 23, 2026
- ❖ **February 14th** - the last day for the BOE to **RECEIVE** a change of enrollment (by mail or in person) for the June Primary (any change of enrollment made between February 15th-June 30th, shall be effective on June 30th).
 - Enrollment changes sent by mail must be **received** by the BOE by February 14th (not postmarked by this date), in order for the party change to take effect for this year's Primary Election.
- ❖ **The Sullivan County Board of Elections will be open from 9:00 AM until 5:00 PM on Saturday, February 14th to receive change of enrollments**

RESOLUTION INTRODUCED BY GOVERNMENT SERVICES COMMITTEE TO AUTHORIZE THE EXECUTION OF THE 2026 ANNUAL CONTRACT BETWEEN THE COUNTY OF SULLIVAN AND CORNELL COOPERATIVE EXTENSION

WHEREAS, the County of Sullivan contracts with various agencies for services; and

WHEREAS, the annual contract, which will include services such in the areas of Ag & Food systems, environmental & natural resources, community & economic vitality, nutrition & healthy families, family development, and youth development agricultural related services, needs to be renewed for 2026 to assure continued delivery of service and payments; and
