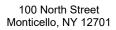

Board of Elections Report Government Services March 6, 2025

- -The Board of Elections created two (2) new Election Districts in February (Fallsburg 13 & Thompson 13), which was required due to the formation of the Village of Ateres
- -All Changes of Enrollment received after the February 14, 2025 deadline, shall be effective July 1st (<u>after the June 2025 Primary</u>)
- -We processed approximately 500 Changes of Enrollment since December 2024 until February 14, 2025

- ❖ The first day to sign a Designating Petition is February 25th
- ❖ The filing period for Designating Petitions is March 31st-April 3rd

RESOLUTION INTRODUCED BY THE GOVERNMENT SERVICES COMMITTEE TO AUTHORIZE THE SUBMISSION OF A NEW YORK STATE ARCHIVES GRANT APPLICATION FOR SULLIVAN COUNTY FOR LOCAL GOVERNMENT RECORDS MANAGEMENT IMPROVEMENT FUNDS.

WHEREAS, the New York State Education Department / New York State Archives has made available 2025-2026 Local Government Records Management Improvement Funding (LGRMIF) which can be utilized to help local governments establish records management programs or develop new program components; and

WHEREAS, an object of the funding is for a document conversion and access project specific to maps and accompanying content; and

WHEREAS, the maximum reimbursable grant award is up to \$75,000.00 with no matching requirement; and

WHEREAS, the Sullivan County Clerk's Office, would like to submit a LGRMIF grant application requesting funds to conduct a back-file conversion scanning of various maps within the Clerk's office; and

NOW, THEREFORE, BE IT RESOLVED, that the Sullivan County Legislature hereby authorizes the County Manager, Chairman of the County Legislature, and / or their authorized representative (*as required by the funding source*) to execute any and all necessary documents to submit the LGRMIF application for funding; and

BE IT FURTHER RESOLVED, that the Sullivan County Legislature hereby authorizes the County Manager, and / or Chairman of the County Legislature (*as required by the funding source*) to accept the award, and enter into an award agreement or contract to administer the funding secured, in such form as the County Attorney shall approve; and

BE IT FURTHER RESOLVED, that should the funding be terminated, the County shall not be obligated to continue any action undertaken by the use of this funding.
