RESOLUTION INTRODUCED BY THE PUBLIC WORKS COMMITTEE AUTHORIZING THE FILING OF AN APPLICATION, FOR A STATE GRANT IN-AID FOR A MUNICIPAL WASTE REDUCTION AND RECYCLING COORDINATION / EDUCATION PROJECT AND SIGNING OF THE ASSOCIATED STATE CONTRACT IF OFFERED, UNDER THE APPROPRIATE LAWS OF NEW YORK STATE.

WHEREAS, the State of New York provides financial aid for municipal waste reduction and municipal recycling projects; and

WHEREAS, from time to time, in the course of their official duties, the Sullivan County Sheriff's Office and the Sullivan County Probation Department are required to seize animals; and

WHEREAS, when animals are seized as part of the County's legal responsibilities, the County is obligated to make arrangements for providing appropriate and proper care for the animals; and

WHEREAS, Catskill Animal Rescue, Inc responded to RFP 23-32; and

WHEREAS, the County wishes to enter into a contract with Catskill Animal Rescue for a two-year period commencing January 1, 2024 through December 31, 2025, with the option to renew annually for three (3) additional years at an amount not to exceed \$60,000 per year.

NOW, THEREFORE, BE IT RESOLVED that the County Manager is hereby authorized to execute an agreement with Catskill Animal Rescue for a period of January 1, 2024 through December 31, 2025, with the option to renew annually for three (3) additional years at an amount not to exceed \$60,000 per year, to provide accommodations for seized animals other than dogs seized by the County as part of the responsibilities of the Sheriff's Office, Probation Department or otherwise required by law, said agreement to be in a form approved by the County Attorney.

WHEREAS, the Sullivan County Sheriff's Office has in the past provided one or more Deputy Sheriffs as School Resource Officers to the Eldred Central School District and the Monticello School District; and

WHEREAS, due to the success of the program and the need for law enforcement in these districts, Eldred and Monticello School Districts desire to continue to have one or more School Resource Officers on their campuses commencing with the 2023-2024 school year; and

WHEREAS, the Monticello School District has requested to have two (2) additional School Resource Officers on their campus for the term of September 1, 2023 to June 30, 2024; and

WHEREAS, the Sullivan County Sheriff's Office recommends that the County enter into agreements with Eldred and Monticello School Districts to provide up to two (2) School Resource Officers in Eldred School District and up to four (4) School Resource Officers in the Monticello School District commencing with the 2023-24 school year; and

WHEREAS, the Districts will reimburse the County of Sullivan 70% of the School Resource Officers cost, with a maximum reimbursement of \$70,000 per deputy and additionally up to \$2,000.00 per deputy for training costs.

NOW, THEREFORE, BE IT RESOLVED, that the County Manager is hereby authorized to execute School Resource Officer agreements with Eldred and Monticello School Districts for the 2023-24 school year, renewable on an annual basis for up to three (3) additional years; and

WHEREAS, the NYS Office of Mental Health provides for regional suicide prevention and mental health crisis helplines throughout NYS, also known as 9-8-8, which is an over-the-phone resource for individuals suffering from a mental health crisis or condition, and

WHEREAS, Dutchess County Department of Behavioral & Community Health serves as the regional 9-8-8 call center location for callers in the Sullivan County area, and

WHEREAS, 9-8-8 calls are answered by mental health professionals that are trained to mitigate and connect callers experiencing a mental health crisis with the help and services they require, and

WHEREAS, Sullivan County 911, like several other 911 centers have done successfully in NYS, wishes to implement a 9-8-8 diversion program of mental health callers of lower acuity in order to connect them for evaluation and referral by 9-8-8 mental health professionals, and

WHEREAS, the Sullivan County EMS & Law Enforcement leadership has endorsed this policy as a means of connecting callers with lower acuity mental health needs with mental health professionals; thereby reserving resources for higher acuity calls, and

WHEREAS, Sullivan County Deputy Commissioner Melissa Stickle has been involved in developing this policy along with her office.

NOW, THEREFORE, BE IT RESOLVED, that the attached policy for 9-8-8 diversion is approved by the Sullivan County Legislature as an addition to the Sullivan County 911 Center Standard Operating Guidelines.

Subject: Mental Health Call Diversion (Helpline)				
Section: 701	Revised:	Established: 8/30/23		

POLICY:

To establish a process for the diversion of persons in Sullivan County having a mental health emergency who do not require an immediate EMS or Law Enforcement Response to the 988 Helpline for further interview.

PROCEDURE:

- 1. Dispatch staff shall create a Call for Service in the CAD system.
- 2. Dispatch staff shall obtain answers to Preliminary call entry questions using open-ended questioning.
- 3. Should the caller present with an apparent mental health emergency with no other obvious need for a Police, Fire or EMS response the incident can be further evaluated for a Helpline transfer.
- 4. If the caller/patient in non-violent and cooperative and also there are no weapons involved the caller should be screened for a possible Helpline transfer.
- 5. Staff will use the latest Helpline Diversion Procedure questionnaire and flow chart, concluding with offer of a voluntary transfer to Helpline.
- 6. Should the caller agree to a Helpline Transfer, call will be transferred to Helpline using 845-486-9057.
- 7. The caller will be introduced to the Helpline representative and the Call Taker will provide CFS number and a brief summary of the incident.
- 8. The Call Taker will assign the Call for Service Type of "Non Emergency" and tag the Call for Service with the disposition code of "988 Helpline".



WHEREAS, the County of Sullivan Multi-Jurisdictional Hazard Mitigation Plan ("HMP") is set to expire on 4/27/2026 and must be updated prior to said expiration date; and

WHEREAS, the County of Sullivan must update and maintain the HMP in order for itself and / or its' municipalities, to be eligible for Mitigation Funding Assistance from the Federal Emergency Management Agency ("FEMA"); and

WHEREAS, the County of Sullivan has identified Federal funding being made available by the Building Resilient Infrastructure and Communities ("BRIC") program, which supports states, local communities, tribes and territories as they undertake hazard mitigation projects, reducing the risks they face from disasters and natural hazards; and

WHEREAS, the BRIC program provides financial assistance to eligible applicants to update hazard mitigation plans and reimburse applicants for said update costs; and

WHEREAS, the BRIC program provides for 75% funding of the total project cost, subject to a 25% County local match of funding, which can be met in either cash or in-kind contribution; and

WHEREAS, the County of Sullivan anticipates a total project cost of \$200,000.00 to update the HMP, and seeks to apply for up to 75% (\$150,000.) in funding of the total project cost, and will provide a 25% (\$50,000.) local match to the BRIC program in the form of cash or in-kind contribution.

NOW, THEREFORE, BE IT RESOLVED, that the Sullivan County Legislature hereby authorizes the County Manager, Chairman of the County Legislature, and / or their authorized representative (as required by the funding source) to execute any and all necessary documents to submit the BRIC program application for funding; and

BE IT FURTHER RESOLVED, that the Sullivan County Legislature hereby authorizes the County Manager, and / or Chairman of the County Legislature (as required by the funding source) to accept the award, and enter into an award



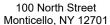

WHEREAS, the County Treasurer is the Real Property Tax Enforcement Officer for the County of Sullivan pursuant to the Real Property Tax Law of the State of New York; and

WHEREAS, the County Treasurer filed a List of Delinquent taxes on or about November 1, 2019 which included the parcel known as Fallsburg 11.-1-39.02./0101; and

WHEREAS, the County Treasurer filed a List of Delinquent taxes on or about November 1, 2020 which included the parcels known as Delaware 15.-2-35 and Thompson 48.-1-56; and

WHEREAS, the County Treasurer filed a List of Delinquent taxes on or about November 1, 2021 which included the parcels known as Bethel 46.-13-7, Bethel 55.A-1-76, Fallsburg 51.-2-22, Forestburgh 30.-2-4.1 and Lumberland 5.-11-9; and

WHEREAS, the County Treasurer previously commenced tax foreclosure proceedings for unpaid taxes and foreclosed upon all of the parcels set forth above; and

WHEREAS, all of the above-mentioned parcels meet one or more of the criteria so that they should be withdrawn from the foreclosure proceeding pursuant to §1138 of the Real Property Tax Law, in that there is a significant risk that it might be exposed to a liability substantially in excess of the amount that could be recovered by enforcing the tax lien and the taxes due have been cancelled or will be subject to cancellation pursuant to §558 of the Real Property Tax Law; and

WHEREAS, the County Treasurer has determined that the commencement of supplementary proceedings against said parcels in the Towns of Bethel, Delaware, Fallsburg, Forestburgh, Lumberland and Thompson pursuant to §1138(5) of the Real Property Tax Law in the manner provided by §990 of the Real Property Tax Law would not be an effective means to enforce collection of the delinquent tax liens at the present time for the following reasons:

Bethel 46.-13-7

This parcel is a 30' x 250' undeveloped road which was created by the filing of a subdivision map. The dedication of the parcel to the County or Town should have been done by the applicant at the time of the filing of the subdivision, but was never accomplished. The Real Property Tax Department no longer permits parcels of this nature to be created in any Town.

Bethel 55.A-1-76

This parcel is a 4 acre landlocked parcel of land which was created by the filing of a subdivision/lot improvement map in 2006. Since that time, the owner of this parcel has been "unknown" and the taxes have been paid by a third party (non-owner). That third party has since stopped voluntarily paying taxes on this parcel. The parcel is adjacent to several parcels and all owners have been afforded an opportunity to purchase

this lot, but none have offered to do so.

Delaware 15.-2-35

This parcel is a 20' x 200' right of way which was created by the filing of a subdivision map. The dedication of the parcel to the County or Town should have been done by the applicant at the time of the filing of the subdivision, but was never accomplished. If this parcel was formally dedicated to the County or Town, it would be removed from the tax rolls, so there is no harm to the County in requesting the relief herein.

Fallsburg 11.-1-39.02./0101

This parcel is a free-standing condominium unit in the fire-damaged development known as "Grandview Palace". After investigation, the parcel is not connected to any utilities due to the surrounding conditions of the lot. Further, access to the parcel is limited due to the fact that the entire area is fenced off due to the unsafe nature of the remaining burned-out buildings surrounding the parcel.

Fallsburg 51.-2-22

This parcel is a small 20' x 233.07' strip of land/road. The parcel is adjacent to several parcels and all owners have been afforded an opportunity to purchase this lot, but none have offered to do so.

Forestburgh 30.-2-4.1

This parcel is a small 10' x 490' (0.11 acre) strip of land/road created in 1938. The parcel is adjacent to several parcels and all owners have been afforded an opportunity to purchase this lot, but none have offered to do so.

Lumberland 5.-11-9

This parcel is a 100.8' x 119' landlocked parcel of land which was created by the filing of a subdivision/lot improvement map in 1960. The parcel is adjacent to several parcels and all owners have been afforded an opportunity to purchase this lot, but none have offered to do so.

Thompson 48.-1-56

This parcel is a small 1' x 1694.01' strip of land which was created in 1957 for an unknown purpose. 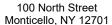
