Catherine Scott moved to Amend Paralegal to the requested dollar amount in the County Attorney's office to \$73,538, seconded by Amanda Ward all in favor with none opposed.

This resolution was put to a Roll Call Vote, all in favor with Terry Blosser Bernardo opposed.
