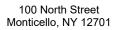

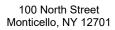
Thank you for the opportunity to offer this report, my apologies for not being present. I am away at an amazing training opportunity, funded by the New York State Division of Homeland Security and Emergency Services Office of Counter Terrorism, with the Association of Threat Assessment Professionals, which I committed to prior to the restructuring of Committee schedules. In light of those changes, this is an abbreviated report covering only from January 17th - January 29th.

Old Business:

- The Sheriff and I are immensely grateful for this Committee and the entire Legislature's support in funding our immediate communications and situational awareness needs. As part of our ongoing modernization initiatives, we identified gaps and you all allowed us to fill them. We have already begun the process of sourcing and procuring those resources that will allow us to assist local emergency response agencies.
- Rabies Control
 - O Between 1/7 1/25 (18 days) the RCO has responded to 11 exposures across 7 townships. Dog -5; Cat -6
- 2024 close-out for the Office of Homeland Security and Emergency Management: 9 EOC activations for real-world incidents, 1 for a Functional Exercise.

New Business:

- I met with our DHSES partners to discuss their initiative focusing on flood mitigation. They have
 generously provided each County with a list of flood mitigation equipment that we will utilize to
 bolster our pre-deployed equipment throughout the County. A resolution has been submitted to
 authorize the County Manager to sign the MOU as drafted by DHSES and approved by the
 County Attorney's Office.
- I want to acknowledge Sgt. Starner and many others who worked tirelessly to put together an amazing memorial service for Constable Doug Ketcham who passed away in the line of duty.
- We have had multiple meetings to solidify our efforts toward making a more secure environment within the Government Center for our visitors. Those discussions will continue and I expect formal proposals to this body in the coming months.
- I toured the new Center for Discovery Children's Hospital in Rock Hill, a beautiful facility that will provide state of the art services.
- Lieutenant Crumley, Corporal Kelting and I continue to focus on developing our Threat Assessment Team as well as regularly examining referrals and cases.



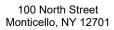

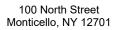

- Our department continues to work as part of the drug taskforce, primarily providing data as needed
- To add to the recent successes reported in this committee from the drug taskforce, I'm happy to report that our statistics also show a decline of 28% in overdose dispatches from 2023 to 2024
- We are working closely with ITS on upgrades to our dispatch workstations and exploring other apps and technology to improve operations
- SEQRA and NEPA review being completed on the Jeffersonville tower project work continues

EMS Report February 2025:

- Working with BOCES to help support continuation of their EMT program offering for high school students
- On January 7th we were able to begin full ALS service with our County Fly-Car system and are averaging a response to 10 ALS level calls per day. We are no doubt improving patient outcomes together with the help of our partners in EMS and other first responders.
- Worked with Garnet Catskills, Division of Public Safety, and Public Health Services on updating and testing our Chempack plan for medication distribution
- Participated in the reorganizational meeting of the Sullivan County EMS Council. They have some good ideas and our office will continue to participate and lend support as needed
- EMT course at SUNY Sullivan will be starting February 24th. There has been some growing interest in the class so if you know someone interested, please sign up to reserve a seat.

Community Events/ Relations/ Training

- *On 1/27/25, our department was notified due to staffing shortage in both Sullivan and Orange Counties, Catholic Charities put a temporary hold on admissions. They will continue to admit DWI court, and Drug Court participants. Otherwise, we are to refer individuals to the Catholic Charities Helpline 24/7 at (845) 794-8080 ext. 4357 (HELP). Catholic Charities are hoping this will only be for a few weeks while staff transition to fill in vacancies in multiple clinic locations.
- * On 1/14/25 Sullivan 180 presented a film on Resiliency to the probation staff
- * On 1/6/25, 1/15/25 and 1/23/25, after hour home contacts were completed. In total, Officers attempted to see 50 offenders, or at least make a collateral contact. In all, 35 probationers were home and seen with no issues reported.
- * 5 staff members attended the American Association of Probation and Parole (APPA) Conference from 1/25-1/29. They were able to see and listen to national speakers regarding effective leadership, supervision, officer wellness, and officer safety. We also met with various vendors regarding programs and tools to enhance supervision.

RESOLUTION INTRODUCED BY THE PUBLIC SAFETY AND LAW ENFORCEMENT COMMITTEE TO AUTHORIZE THE COUNTY MANAGER TO ENTER INTO AN AGREEMENT TO ACCEPT FLOOD MITIGATION EQUIPMENT FROM THE NEW YORK STATE DIVISION OF HOMELAND SECURITY AND EMERGENCY SERVICES (NYS DHSES)

WHEREAS, the New York State Division of Homeland Security and Emergency Services (NYS DHSES) has appropriated funds in the FY2024 budget to purchase flood mitigation equipment to support counties in emergency flood events, enhancing preparedness and response capabilities; and

WHEREAS, the Sullivan County Division of Public Safety seeks to enhance its flood mitigation efforts through the use of state-provided equipment, helping to protect vulnerable areas and mitigate disaster impacts; and

WHEREAS, the Sullivan County Division of Public Safety wishes to enter into a memorandum of understanding with NYS DHSES, establishing the terms and conditions under which NYS DHSES will transfer possession (but not ownership) of flood mitigation equipment to Sullivan County, while retaining oversight to ensure compliance and operational readiness; and

WHEREAS, the equipment to be provided is a one-time allocation, at no cost to the County; and

WHEREAS, it is in the best interest of the County to enter into an agreement with NYS DHSES to enhance our operational readiness.

NOW THEREFORE IT BE RESOLVED, that the Sullivan County Legislature hereby authorizes the County Manager, Chairman of the County Legislature, and/or their authorized representative to execute any and all necessary documents to enter into an agreement with NYS DHSES to accept a one-time allocation of flood mitigation equipment, and that such agreement shall be in a form approved by the County Attorney's Office.
