# RESOLUTION INTRODUCED BY LUIS ALVAREZ, NADIA RAJSZ, JOSEPH PERRELLO AND IRA STEINGART

Whereas without conferring with fellow legislator Luis Alvarez, and

Whereas without referring his alleged concerns to the Commissioner of Human Resources, and Whereas without discussing the content of its decision with John Kiefer, then the Chair of the County Board of Ethics or with any other member of that Board, and

Whereas without seeking the assent of the County Attorney or this body for issuing his press release, and

Whereas on January 22, 2021, Robert Doherty issued a press release in the name of this body and then further had it publicized on the County's website and falsely claimed therein as a fact that Mr. Alvarez directed a vile term toward then Commissioner Brown and further defended this claim by repeatedly writing that this claim was "founded" when he knew that it had never been founded or even investigated

by either Julie Diescher, the Commissioner of Human Services, or the Ethics Board, **Whereas** after a full and fair trial, which itself followed extensive discovery, a jury of his peers has unanimously determined that Mr. Doherty lied and defamed Mr. Alvarez in claiming that he made any such statement to Ms. Brown and in asserting that this claim has been "founded", and **Whereas** after the trial and jury verdict, Mr. Doherty issued a press release in which he continues to stand by his false claims, re-defaming Mr. Alvarez with his lies.

#### It Is Now Hereby Resolved that:

- 1. Mr. Doherty shall now, and is hereby immediately removed as Chairperson of the Legislature;
- 2. This body condemns Mr. Doherty for the making and publication of false statements, particularly such statements which relate to matters which should have been subject to private investigation and review pursuant to the processes established in and by this County, and
- 3. This body apologizes to Stephanie Brown for Mr. Doherty's unauthorized publication and to Mr. Alvarez for the public humiliation and disgrace which Mr. Doherty intended to and did cause by and through said publication.

Chairman Steingart called the question on the resolution, the resolution failed 2-3 with Michael Brooks, Nicholas Salomone and George Conklin opposed.

#### Adjourn

There being no further business, Nadia Rajsz moved to adjourn, seconded by Michael Books. the Planning, Real Property and Economic Development Committee adjourned at 10;53AM.
