Invasive Species of Sullivan County (2/12): 30 people attended the webinar. Topics covered included: identification, habitat, management and prevention of invasive species that are present in Sullivan County.

We held the Produce Safety Alliance Growers Trainings in February at 2 locations: Pennsylvania training location: 2/20/25- Honesdale, PA, New York training location (2-day): 2/26 & 2/27, Liberty, NY, where 25 attendees received their certificate from the Association of Food and Drug Officials (AFDO).

The Cornell Cooperative Extension Livestock Program Work Team is comprised of educators working to build a collaborative network of experts and resources to foster the success of livestock farms across NYS. Michelle Proscia, the CCE Sullivan Ag Program Manager actively participates in this work team, developing regional and statewide resources and programs.
