Topic: Opioid Settlement Funds Date: September 14, 2023

Issue Summary: In 2021, settlements resolved opioid litigation against the nation's three largest distributors and against manufacturer Johnson & Johnson. In late 2022, agreements were announced with three pharmacy chains—CVS, Walgreens, and Walmart—and two manufacturers—Allergan and Teva. Under the National Settlements, at least 85% of the funds (known as "restricted use funds") going directly to participating states and subdivisions must be used for abatement of the opioid epidemic. To date, the County has received \$1,750,424.80 from the trusts setup by these corporations. Of that total, \$1,080,348.80 was provided directly to the County from the trusts and \$670,076 was disbursed to the County by OASAS from the State-level settlement. The timeframe of payments differ; some companies are providing one-time payments, some over several years. One will pay out over the next 16 years. We continue to await the results of additional settlements, especially from Purdue Pharma, which is likely to be the single largest payout of all. Our current total anticipated from settlements already resolved (not including Purdue, et al) is approximately \$7.9million.

<u>Approved Uses</u>: Each settlement includes a ~12 page list of approved uses of settlement funds. A chart with the complete list of categories of approved uses is included below. Expenditures in support of law enforcement operations are not included in the "restricted use" category of all settlements. Of funds received so far, \$748,742.47 may be utilized by law enforcement and considered "restricted use."

**2022-23 Opioid Settlement Budget Chronology**: The conceptual work behind the county's first opioid settlement fund budget started at a Drug Task Force Pillar meeting in September 2021. Inputs were sought over the next several months from all pillar leads and members of the community, including at a well-attended public meeting covered by the *Sullivan County Democrat* and other local news outlets on March 25, 2022. A system was developed with 10 different grading criteria to prioritize projects, and a **list of 18 funding requests was ultimately submitted to the Legislature and approved unanimously on June 16, 2022.** The complete list of requests and a summary status of each follows. It is important to note that funds not utilized are *not* subject to recovery by the State or Federal government because they are not appropriated to Sullivan County by higher level authority; expenditures of these funds are at the discretion of the County Legislature. The following authorizations were made for a 12-month period in an effort to ensure timely expenditure. Recommendations to re-authorize funding are included where applicable.
