Kevin J. Giroux, Conductor



Kevin J. Giroux is in his 26th year as the Choral Director at Tri-Valley Central School, located in Grahamsville, NY. Prior to his tenure at Tri-Valley, Mr. Giroux taught for two years at Saranac Lake Central School. His instructional duties at Tri-Valley include a 9-12 chorus, Music Theory, 7th Grade General Music, and 9-12 voice lessons.

Mr. Giroux is a very active member of his school community. His previous advisorships included: co-advisor of the Tri-Valley yearbook, co-advisor of Tri-Valley's Chapter of FBLA (Future Business Leaders of America), and Entertainment Director of Grahamsville's Little World's Fair. Currently he is the co-advisor of the National Honor Society and co-Graduation Coordinator. Mr. Giroux is very supportive of his students' athletic endeavors, and can be seen at many of their

events cheering them on or working on the sidelines.

Mr. Giroux's outside music activities include being a NYSSMA (New York State School Music Association) All State solo adjudicator, former Zone 9 Representative (Greene, Sullivan, Ulster, Orange, and Rockland Counties) and is the immediate past All State Chorus Chair. He is also a Past-President and current Treasurer of the Sullivan County Music Educators Association, a frequent guest conductor for county and NYSSMA Area All State festivals, Conductor of the Sullivan County Community Chorus, and church organist.

Mr. Giroux, a native of Plattsburgh, NY, received his Bachelors of Music Education from the Crane School of Music at SUNY Potsdam in 1996, and his Masters in Music Education from Ithaca College in 2002.



Keira Weyant received her Music Education degree from Ithaca College in 2000 as a piano major. She spent five years at Roscoe Central School as the Vocal Director, where she could combine her love of music with her love for teaching children. When she and her husband started a family, Mrs. Weyant decided to resign from her position to stay home with their children full time. She has since returned to the classroom and is a music teacher at Tri-Valley teaching 4th Chorus, 5/6 Chorus, 7/8 Chorus, 5th Grade General Music, as well as 7/8 voice lessons.

Mezzo-soprano Nicole Rizzo is a performer from Upstate New York who finds joy in sharing opera with new audiences. Season highlights include *Le Prophète* with Bard SummerScape, *Faust* with Berkshire Opera Festival, and *Orphée aux enfers* (Junon) with Bard College Conservatory at the Fisher Center. She holds a Bachelor of Music from Boston Conservatory at Berklee, where she performed in several opera productions, including *The Turn of the Screw* (Mrs. Grose), *The Consul* (Vera Boronel), and *Dialogues des Carmélites* (Mère Jeanne). Nicole has served as an Affiliate Artist at Union College, performed with Boston Lyric Opera, and gave a recital at the Sembrich Museum

in Bolton Landing, NY with pianist Michael Clement. Other recent performances include *Roméo et Juliette* (Stéphano) with the Brevard Music Center, *A Little Night Music* (Charlotte/Petra) with Opera in the Ozarks, and *Cendrillon* (Dorothée cvr.) with Promenade Opera Project. Nicole recently completed her first year of the Graduate Vocal Arts program at Bard College Conservatory.



Joseph Breslau is a baritone in his first year in the Vocal Arts Program at Bard College studying with Mr. Richard Cox, and aims to balance his focus on opera, new music, and German Lieder performance. Joseph has sung the roles of Papageno, Aeneas, Duncan, Sid, and Jupiter from Mozart's *The Magic Flute*, Purcell's *Dido and Aeneas*, Ernest Bloch's *Macbeth*, Britten's *Albert Herring*, and Offenbach's *Orphée aux enfers*. In 2022, Joseph performed as a soloist with the Case Western Reserve University Baroque Ensemble in performances of music by Purcell,

A. Gabrieli, and L. de Sayve. Joseph has premiered 5 new pieces by composers from the Cleveland Institute of Music, Arseny Gusev's 5 Sunset Songs and Micro-Opera The Blind, Yoav Sadeh's Loneliness: A monodrama for soloist and ensemble, Daniel DiMarino's Micro-Opera Ruth, and Noah Hertzman's song Birches.

Program Notes

My Childhood Home: Daniel McDavitt has composed an exquisite trilogy using texts from three American greats: Ralph Waldo Emerson, Abraham Lincoln, and William Wordsworth. The second "memory," which we are performing this afternoon, is from Lincoln, and is more reflective about childhood.

[From the composer] Three Memories was commissioned by the Deer Creek Chorale (Martha Banghart, director) to be premiered in April 2017 for a concert on the theme of music and memory, specifically drawing attention to Alzheimer's Disease and dementia.

This piece was very personal for me. Much of the inspiration for the music in *Three Memories* comes from observations of my grandmother as she was in the later stages of dementia. She was forgetting all of the small details, like the day of the week, the time of day, the month or season of the year. She often forgot who I was, or others in the family. She'd reach for a butter knife and hold it for a few minutes trying to figure out what it was she was supposed to do with it.

But I also noticed how sounds triggered her memory. The sound of a dog barking next door reminded her of something I did when I was a toddler. The sound of a bird reminded her of a clock they used to hang in their old house. The sound of music reminded her of my piano recitals, and she could remember the words of old hymns. Yet she didn't know what to do with a butter knife.

Thus, when I was invited to consider texts for this commission, I sought texts that highlighted things that can bring memories back, and that bring with them hope, comfort, and joy. As I reflect on the experiences I had with my grandmother — and the tender mercy it was to hear her tell me stories of my childhood, when all the while she couldn't remember what to do with her butter knife — I see the powerful meaning in the final statement in the third movement, "And yet a wiser mind mourns less for what age takes away, than what it leaves behind."

The flute is a representation of memory, and takes inspiration from my grandmother's responses to the sound of birds. In the first movement it is upbeat, even jocular, as the text speaks of finding music in all of the world, from the bird in the sky to the mud on the ground. The second movement is more of an atmospheric piece, as though standing at the bottom of a tall waterfall, with the flute soaring very high above. In the final movement, the flute introduces a simple three- note theme (mi-do-sol) when it first enters. From there it is woven into the piece rather subtly, though by the end, all of the parts have a chance to sing it. The whole piece ends with this simple three-note theme presented a little broken up, as if the memory is there but it takes a moment to bring it all together.

Three Memories is dedicated to the memory of my paternal grandmother, Virginia Zupka McDavitt.

When Memory Fades: Life yields many circumstances we cannot avoid. As mortals, our bodies grow frail, and our mental capacities may diminish over the years. What does one do in these instances? Mary Louise Bringle (b. 1953) wrote the text of *When Memory Fades* for a friend whose mother was suffering from Alzheimer's disease. Dr. Bringle's sensitivity to this passage in life's journey and attentiveness to the needs of the world has contributed to her recognition as one of the leading hymn writers in the English language today.

When memory fades and recognition falters, when eyes we love grow dim, and minds, confused, speak to our souls of love that never alters; speak to our hearts by pain and fear abused. O God of life and healing peace, empower us with patient courage, by your graced infused.

When Memory Fades is a hymn that touches on life, both mortal and spiritual. This hymn text, prompting one to acknowledge the frailty and inadequacies of our earthly vessels, looks to God, who is the source of all life. Dr. Bringle guides the singer through emotions of petition, grieving, and gratitude. Rather than asking for healing, she is concerned about remembering and declaring who God is in the midst of this situation.

Professor Bringle draws heavily upon Scripture, especially referencing the psalms and the epistles. Stanzas one and two address the experience of pain. The second half of each stanza addresses God. "O God of Life and healing peace" (stanza one) suggests Psalm 36:9, where God is declared the giver or fountain of life. The last line of stanza one "with patient courage" strongly echoes the sentiments of Psalm 31, "Be of good courage, and he shall strengthen your heart" (KJV). The text leading into line four of stanza one petitions God to "empower us," and concludes with strength gained through God's "grace infused." Second Corinthians 12:9 declares that "my [God's] grace is sufficient." Encouraged by Paul to "fight the good fight," the servant is comforted by the psalmist's words, "The Lord is my strength."

As the frailness grows, and youthful strengths diminish, In weary arms, which worked their earnest fill.

Your aging servants labor now to finish...
Their earthly tasks as fits your mystery's will.
We grieve their waning, yet rejoice, believing,
Your arms, unwearied, shall uphold us still.

Stanza two of "When Memory Fades" speaks of God's will as a mystery still being completed by God's servants. "For I know the thoughts that I think toward you, saith the Lord, thoughts of peace, and not of evil, to give you an expected end" (Jeremiah 29:11, KJV). While it is unknown to the servants, Jeremiah assures the servant that God knows our every need. The calm assurance of the God who will sustain us concludes stanza two.

The poet begins the final stanza by declaring the eternal nature of God's love and ends with the declamatory statement "deathless life is won!" Hebrews 6:10 reminds us of the following, "For God is not unrighteous to forget your work and labor of love" (KJV). Because in Christ we are freed from sin (Romans 8), we can receive the gift of eternal life (Romans 6:23); even when strength and memory fail us, we cannot lose this promise.

One of the most significant gifts of this text is how the hymn writer gives dignity and theological meaning to God's "aging servant." In spite of the present situation, God's "goodness lives unfading," a statement in antithesis to fading memories in the first line of stanza one.

Within your spirit, goodness lives unfading.
The past and future mingle into one.
All joys remain, un-shadowed light pervading.
No valued deed will ever be undone.
Your mind enfolds all finite acts and offerings.
Held in your heart, our deathless life is won.

Present suffering becomes more bearable and gains perspective when we draw upon memories of the past and hopes for future resolution. Then the poet, in a richly reverberant phrase, seizes on a central thought that places into context the condition of one suffering from loss of memory and dignity: "no valued deed will ever be undone."

From a broader theological perspective, this hymn may be seen as Trinitarian. In stanza one, the author makes a direct reference to God ("O God of Life"), asking for the empowerment of grace. Stanza two speaks of the aging process, an incarnated bodily progression. That process includes becoming weak and tired. The phrase, "Your arms, unwearied, shall uphold us still," suggests an image of Christ on the cross. The final stanza addresses the third member of the Godhead, the Holy Spirit (https://www.umcdiscipleship.org/resources/history-of-hymns-when-memory-fades).

I Will Live: This modern concert piece was inspired by those who leave us too soon and reminds us that they live on in our memories. A unison melody cascades into falling treble harmonies, then picks up with a rhythmic drive in a tenor-bass feature that expands into full choir with soaring melodic lines and beautiful clusters and suspensions.

Stellae in aeternum. Forever with the stars.

Alzheimer's Stories: [Composer's Notes] Alzheimer's Stories is a large work for soloists, chorus and large ensemble. It was commissioned by the Susquehanna Valley Chorale and is based on the libretto by Herschel Garfein, which tells recollections of chorus members and friends with relatives who've had the dreaded disease. It was

premiered on October 9, 2009 at the Weis Center for the Performing Arts conducted by Dr. William Payn. It was recorded for broadcast by PBS television station WVIA and subsequently performed throughout the U.S and Europe.

In 2008, a member of the Susquehanna Valley Chorale who asked to remain anonymous made a donation to the chorale to help fund the commissioning of a musical work on the subject of Alzheimer's disease to honor his parents, who had both died of it. In collaboration with 2012 Grammy Award winning opera librettist Herschel Garfein (Elmer Gantry), a blog was set up on the choir's website www.svcmusic.org to record stories by chorus members and the local community describing experiences with relatives and friends who had Alzheimer's disease with a selected group of those stories becoming the basis for the work: Alzheimer's Stories for soloists, chorus and large ensemble.

The work is in three movements the arc of which loosely mimics the progression of the disease:

<u>The Numbers</u> – an objective description of the discovery of the disease by Dr. Alois Alzheimer in 1901 including the number of individuals currently afflicted, future projections and dramatized conversations between Dr. Alzheimer and his first patient, Auguste Dieter. The movement ends with an extended setting of a quote from his patient, "Ich hab mich verloren," "I have lost myself."

<u>The Stories</u> – a pastiche of a number of selected stories taken from the choir's blog. With a mixture of pathos, poignancy and humor, we meet a number of individuals afflicted with the disease, portrayed by the two soloists, as well as the recollections of family members. Two notables: a woman who still thinks she's on a boat to Panama with her father; and a WWII Navy veteran who repeats the same bawdy story of the war so many times that the chorus can recite it by heart.

<u>For the Caregivers</u> — The most difficult part of writing a work about such a terrible and ultimately hopeless disease was how to end the work with some semblance of hope. The clue came in a recollection by one of the chorus members about a visit to a nursing home where a patient asked them to sing. When asked what, the patient replied: "Sing anything." First referenced in the second movement, this idea became the centerpiece and focus of the last movement. The core of the brilliantly realized libretto is as follows:

Find those you love in the dark and light.

Help them through the days and nights.

Keep faith. They sense what they cannot show.

Love and music are the last things to go. Sing anything.

Alzheimer's Stories received its world premiere on October 9, 2009 performed by the Susquehanna Valley Chorale at the Weis Center for the performing arts in Lewisburg PA in a program entitled "Monument to Memory." It was recently performed at Carnegie 12Hall by the San Antonio Mastersingers and is scheduled to be there again in April 2020.

According to the 2024 Alzheimer's Disease Report: Facts and Figures, these are the most recent statistics on the disease.

- Approximately 6.9 million Americans have Alzheimer's disease (AD). Unless a cure or prevention is found, that number will increase to between 11 and 16 million by 2050.
- The percentage of people with Alzheimer's dementia increases with age: 5.0% of people age 65 to 74, 13.2% of people age 75 to 84, and 33.4% of people age 85 and older have Alzheimer's dementia.
- Direct and indirect costs of AD and other dementias amount to more than \$360 billion in 2024.
- Over 11 million Americans are caring for a person with Alzheimer's disease or another dementia; Just in NY, approximately 543,000 unpaid caregivers are providing care to the 426,500 individuals with the disease this equates to 879 million hours of unpaid care at a cost of 18.9 billion dollars per year.
- NY ranks 4th in the number of Alzheimer's disease cases and 10th in the number of AD deaths.
- A new person develops Alzheimer's disease every 65 seconds this is projected to increase to every 33 seconds by 2050.
- Between 2000 and 2021, the number of deaths from Alzheimer's disease as recorded on death certificates more than doubled, increasing 141%, while deaths from the number-one cause of death (heart disease) decreased 2.1%, while stoke decreaed 2.8%, HIV decreased 65.6%, breast cancer increased 1.2%, and prostate cancer increased 4.8% over the same time period.

Sing You Home: This original song by Canadian songwriters Mark Murphy and Maureen Ennis, originally written for vocal trio and heard in various memorial occasions, has now been arranged by Dan Forrest, Jamie Hillman, and the composer. The gentle "songwriter" feel of the original is supported by a simple piano accompaniment and well-crafted choral lines. The result is a deeply-felt expression of grief and comfort: "I'll sing for you because I need to, right now this is all I know; I'll sing so we will not forget you, I will sing you home - I will sing you home."

Amazing Grace is a Christian hymn published in 1779, written in 1772 by English Anglican clergyman and poet John Newton (1725–1807). It is an immensely popular hymn, particularly in the United States, where it is used for both religious and secular purposes.

Newton wrote the words from personal experience; he grew up without any particular religious conviction, but his life's path was formed by a variety of twists and coincidences that were often put into motion by others' reactions to what they took as his recalcitrant insubordination. He was pressed into service with the Royal Navy, and after leaving the service, he became involved in the Atlantic slave trade. In 1748, a violent storm battered his vessel off the coast of County Donegal, Ireland, so severely that he called out to God for mercy. While this moment marked his spiritual conversion, he continued slave trading until 1754 or 1755, when he ended his seafaring altogether. Newton began studying Christian theology and later became an abolitionist.

Ordained in the Church of England in 1764, Newton became the curate of Olney, Buckinghamshire, where he began to write hymns with poet William Cowper. *Amazing Grace* was written to illustrate a sermon on New Year's Day of 1773. It is unknown if there was any music accompanying the verses; it may have been chanted by the congregation. It debuted in print in 1779 in Newton's and Cowper's *Olney Hymns*, but settled into relative obscurity in England. In the United States, *Amazing Grace* became a popular song used by Baptist and Methodist preachers as part of their evangelizing, especially in the American South, during the Second Great Awakening of the early 19th century. It has been associated with more than 20 melodies. In 1835, American composer William Walker set it to the tune known as "New Britain" in a shape note format; this is the version most frequently sung today.

With the message that forgiveness and redemption are possible regardless of sins committed and that the soul can be delivered from despair through the mercy of God, *Amazing Grace* is one of the most recognisable songs in the English-speaking world. American historian Gilbert Chase writes that it is "without a doubt the most famous of all the folk hymns" and Jonathan Aitken, a Newton biographer, estimates that the song is performed about 10 million times annually.

It has had particular influence in folk music, and has become an emblematic black spiritual. Its universal message has been a significant factor in its crossover into secular music. *Amazing Grace* became newly popular during the 1960s revival of American folk music, and it has been recorded thousands of times during and since the 20th century (Wikipedia.com).
