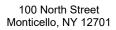

I. PLANNING ACTIVITY

- Updated exemption agreements were sent to municipalities for renewal. To date, fifteen municipalities have signed and returned them, and two are due later this month.
- Pace University training on land use law training was held at Cornell. It was well received.

- Working with NYS DEC and the Sullivan County Partnership on a training to update our communities on changes to wetland regulations.
- Planning staff has been attending municipal planning board meetings to foster better coordination and more helpful reviews. The Towns of Liberty, Bethel and Forestburgh's meetings were attended in October.

Land Use, Strategic and Comprehensive Planning

Water Resources and Infrastructure

- Planning and Delaware Engineering continue to have monthly progress meetings for regular updates on the status of the assessment. Delaware has developed the framework to collect data on existing conditions and make recommendations for areas for infrastructure expansion based on current and anticipated growth. Data collection is underway.
- A separate scope of work is being developed to obtain hydrogeologic expertise in relation to subsurface conditions throughout the County to assess the County's water resources. We are actively searching for funding sources that could potentially fund this study.
- Continued facilitation of technical assistance to Wurtsboro and Fallsburg from the Water Center at the University of Pennsylvania.

Hazard Mitigation Plan

- Staff continue to follow up with municipalities that were not able to attend the meeting in June, via one-on-one calls, to discuss the plan and receive updates on projects included in the 2021 update.
- Notification was received by the State that our application for funding has been forwarded to FEMA for final review and determination on a funding award.

Recreation, Quality of Life & Tourism-based Economic Development

Sullivan O&W Rail Trail

- The Neversink Crossing project received NYSDOT is in advanced design review. The current schedule anticipates a bid will be issued before the end of 2024.
- The use and occupancy agreement between NYS DOT and the Town of Liberty for the Parksville extension is tied with the acquisition process for multiple parcels related to the rerouting of Route 17. The engineering has started, but final scoping of the needed surveying needs to be assessed. Planning met with DPW, DOT, the Town and the consultant, Alta to finalize the extent. There are potential impacts to the project budget based on the extent for which surveying and SEQR must be completed. We are waiting for additional information from NYSDOT to determine these impacts.
- The Town of Rockland and their engineers should have the first design draft this month for the Livingston Manor to Dahlia section of the trail.
- Staff continue to participate in monthly meetings of the O&W Rail Trail Alliance as well as regular meetings with the engineering firm and partner municipalities.

- Planning worked with the Sullivan Public Library Alliance to order materials for a daypack lending project to encourage people to use the trail.
- The 2024 HO&WL event (Fri 10/25/24) took place in Mamakating, starting and ending at the Bashakill Vineyard
- The 2025 multi day hike (ROAM) will take place on June 6-8 in Mamakating.

Community Development & Revitalization

Housing Fund

 The Legislature adopted a local law establishing Affordable Housing as a County purpose. The 2024 Operating Budget included \$2 million for local affordable housing initiatives. A discussion is necessary to determine the most appropriate use of those funds. Pattern for Progress has presented a draft outline of how a local housing fund may be structured. Guidance from the Legislature is needed at this time prior to finalizing and moving forward with a program.

Community Outreach

Training for local communities about encouraging housing while protecting community character are being targeted for late November/early December of this year.

Bicycle and Pedestrian Infrastructure Master Plan

- The contract from the NYS Department of Environmental Conservation for the Climate Smart Communities Program funding is fully executed.
- A Request for Proposals has been issued; proposals have been received and reviewed. A resolution is presented today to award a contract to Metropolitan Urban Design Workshop (MUDW).
- We anticipate a kick-off meeting for the plan in early December, and meetings with the Advisory Committee and focus groups beginning early in 2025.
- The plan will focus on connecting residents and visitors in and around community centers (villages, hamlets) with safe pedestrian and bicycle infrastructure.

RESTORE NY Round 7

- Actively working with NYS Empire State Development and RUPCO to implement the RESTORE NY Round 7 award received for rehabilitation of the Strong Building and Key Bank Building on Broadway, Monticello.
- The County is working with RUPCO and the Sullivan County Land Bank to navigate a significant increase in the cost of construction based on the latest cost estimates. RUPCO is waiting for determinations on several grant applications that have been filed for this project.

Economic Development

- **Emerald Corporate Center Economic Development Corporation (ECCEDC)**
 - We continue to work with the Town of Thompson to transfer Emerald Springs Water Company (ESWC) and all assets to the Town of Thompson, based on discussions with counsel having experience with the process.

Administration

- Attended Airport Commission meeting
- Met with County Manager and Management and Budget staff to discuss 2025 budget
- The Research Analyst position has been filled with the newest staff member joining the Planning team on Monday, October 21, 2024.
- Participated in monthly O&W Rail Trail Alliance meeting
- Attended the RUPCO Community Luncheon on 10/16/2024
- Attended the Open Space Institute's open house event in Mamakating for the O&W Feasibility Study from Port Jervis to Kingston
- Attended the Pattern for Progress Housing Conference on 10/22
- Participated in kick-off meeting for the Ag Climate Resiliency Advisory Committee with Cornell Cooperative Extension staff and other community members

OFFICE OF SUSTAINABLE ENERGY (OSE) II.

- Staff met with HVRC staff to discuss recertification efforts for the Climate Smart Communities Program. We anticipate recertification in the third quarter of 2025.
 - It appears that the County is in a position to achieve Bronze Certification based upon efforts to date, once documentation is compiled and a task force is reformalized.
 - The County may be in position to achieve Silver Certification upon completion of several exciting projects, such as the Airport Terminal.
- The Lake Goodyear small hydro facility continues to be offline due technical problems. Gravity Renewables, the operator of the plant, is troubleshooting with NYSEG to resolve the issue. There is no cost to the County for repairs.
- OSE staff have continued to review monthly utility statements, and to work with NYSEG and DPW staff to resolve ongoing issues with meter readings and monthly billings.
- OSE continues to document the County's progress toward reducing energy usage and greenhouse gas emissions while also identifying future clean energy project opportunities.

PARKS, RECREATION & BEAUTIFICATION III.

- The Palisades Interstate Park Commission is reviewing the design and engineering work for the Lake Superior westside hiking trail.
- Fisher Associates have submitted a preliminary schematic design and cost estimates for the parking area and river access trail for the Callicoon Park. The property survey for the permitting is being completed along with the SEQRA process.
- Working with the Grants Department to submit documentation for funding from DASNY for the Callicoon Park.
- Attended the Sullivan County Historical Society annual dinner. The society honored the Frederick Cook Society and Borscht Belt Historical Marker Project.
- Working with the Sullivan County Historical Society members on purchasing a Historical Marker for the Hurleyville School, which is now the Sullivan County museum.
- The department is hosting a Sullivan County Parks Photo Exhibition. Photographs must be taken at one of the departments facilities. Winning photos will be on exhibit from March 1-April 30, 2025, at the Government Center, Monticello and the Sullivan County Cultural Center & Museum, Hurleyville. The winning photos will receive a prize.
- The department has teamed up with The Delaware Company to offer a Ghost Walk at the Minisink Battleground Park. The walk took place at 2:00 pm on October 26, 2024. The event had 75 participants.
- Park Maintenance staff have replaced deteriorated split rail fencing along the D&H Canal trail by the interpretive center.

IV. **GRANTS ADMINISTRATION**

Activity/Technical Assistance

- Since 9/27/24, DGA has received seven funding resource requests related to small business expansion, private school extra-curricular programming, law enforcement agency technology needs, municipal transportation safety planning, a private summer camp, the ADU Plus One program, and a not-for-profit capital project.
- Our Department provides information about grant resources on our web page as a courtesy to the public. The County does not endorse one over the other, nor is the list provided exhaustive by way of available agencies, but fund-seekers and community organizations may engage in additional research and use their discretion in order to meet their particular needs.
- This month, we added several funding resource links to the DGA website, and added a category on AGRICULTURE/FOOD/HOSPITALITY. Other categories include:
 - AGING/SENIORS
 - ANIMALS/PETS
 - ARTS AND HUMANITIES
 - LIBRARIES AND MUSEUMS
 - COMMUNITY INITIATIVES

- Assistance has been provided to departments requiring support with the grant process. Of note:
 - County Manager's Office/OMB/Public Safety: FEMA / NYS DHSES Public Assistance for Disaster Declaration DR#4480 for COVID-19 Emergency Protective Measures Projects: DGA Supervisor and OMB Budget Analyst were asked to respond to and participate in the FEMA and NYS DHSES Recovery Transition Meeting (RTM) which is required as part of the grant administration and closeout process.
 - County staff received positive feedback from FEMA and NYS DHSES staff in the development, submission and overall administration of the Public Assistance for Disaster Declaration DR#4480 for COVID-19 Emergency Protective Measures projects.
 - Given the positive RTM outcome, the County anticipates receiving the total reimbursement for the Project 6 submittal in the amount of \$30,587.13 (5% of Projects 1-5 Total Award) in the near future, as it has moved forward in the FEMA / NYS DHSES processing.
 - Public Health: The County was awarded \$15,000 via the GTSC Child Passenger Safety Seat Program.

- Social Services: DGA staff collaborated with Assemblywoman Gunther's office and the Commissioner of Health and Human Services to present a proposal for consideration under the DASNY CREST program.
- ITS: DGA staff reviewed NY Connect All BEAD (Broadband Equity Access and Deployment Program) funding opportunities in order to assess eligibility for future broadband infrastructure projects. Further discussion will take place related to the County's options, pending the outcome of the Municipal Infrastructure Program grant application.
- Parks and Recreation: DGA staff prepared and submitted NY SWIMS workplan and budget information, which is currently under review by the NYS Department of State NY SWIMS review team. Pending the outcome of the application, DGA is prepared to collaborate with the County Parks and Rec Department and participating municipalities related to the management of the program.
- Planning: DGA staff participated in the 2024 RAISE Grant Debriefing with the Director of Planning, and noted review recommendations.
- Public Safety:
 - DGA staff attended the 2024 DHSES Grants Regional Workshop on Thursday, October 24th with members of OMB and Public Safety staff.
 - Probation received the \$28,520 disbursement for the 2024-2025 Alternatives to Incarceration allocation.
- Public Works:
 - The 2024 NBRC Timber for Transit grant application was submitted for the replacement of Bridge 368.
 - DGA staff has engaged in research to locate firefighting-related grants on behalf of the Sullivan County airport.
- Board of Elections: DGA staff attended a meeting with ITS and BOE staff related to the 2024 Rural and Nonmetro Election Infrastructure Grant in the amount of \$50,000. ITS and BOE staff will continue to collaborate related to the acquisition of technology and the coordination of installation efforts
- Sheriff: The County was awarded \$4,690 for the GTSC Police Traffic Services grant.

TECHNICAL ASSISTANCE:

Farm Visits: 5 Technical Assistance/Inquiries: 75 Soil/Hay Tests: 16

Technical Assistance was provided on soil testing, native plants, pest ID, plant ID, Feral swine, Japanese knotweed, native gardens, permaculture, raising bees, pruning techniques, wildlife control, ag districts, farm funding, farm food safety, livestock processing, orchard management, starting a farm, ag taxes, livestock production, vegetable production, land access.

PAST WORKSHOPS

Juntos Aprendemos: Poultry Production 09/09: 20 attendees, Online Spanish translated webinar with the Cornell Small Farms Futuro En Ag on Poultry Production. Including feed, breed selection, marketing, regulations, nutrition and care.

Farm Beginnings: How to Start Your Own Farm 09/10: 30 registered, 12 attended, Melinda Meddaugh & Michelle Proscia presented on some of the key steps when starting your own farm business and explained some important items to consider and know when building a farm business. Erica Madden, owner and operator of Good Find Farm, shared her experience starting her

own farm and information about her farm business. This event was hosted at the Western Sullivan Public Library Delaware Free Branch.

Silvopasture Farm Tour 09/12/24: 29 registered, 18 attended, A farm tour at All One One All Farm where Alix Daguin taught about silvopasture techniques on their small scale, regenerative farm. The tour covered grazing plans and livestock integration, the ecological benefits of silvopasture and how it can boost farm sustainability and productivity.



Tractor Operation Training 09/13: 10 registered, 8 attended, SG from SG Tractors guided an interactive workshop. Throughout the workshop, folks had hands on learning opportunities and were guided through demonstrations and video tutorials. Participants learned about the 4-stroke engine and how all the parts of the tractor function, basic maintenance, safety, manuals, dashboards, symbols, levers, and how to operate a tractor. This event was held at Stone Wall Farms in Jeffersonville.

Farmer Mixer at Unbroken Acres 09/17: 36 attended, This event was an informal networking opportunity for aspiring, beginner, and seasoned farmers. Owner and operator of Unbroken Acres, Anna Zabirova, hosted this event. Anna provided a tour of the farm, explaining her farm practices and experience in farming. Unbroken Acres is located in Cochecton, NY.

Native Species of the Northeast Webinar 09/18: 11 people attended, Horticulture Educator Katie Gasior taught attendees about native species for our areas and how to incorporate them into your landscape.

Municipal Farm Tour 09/24/24: 10 registered, 8 attended, Municipal officials were invited to tour Somewhere in Time Farm so they could experience a working vegetable farm. Justin gave an overview of his farm operation, the importance of having high tunnels, farm stands, and how agritourism is necessary for his farm to generate reliable income. Melinda provided an overview of the use of high tunnels, production methods, agri-tourism activities, and the benefits of adding a farmstand to the farm.

Farm Food Safety Operators Project Directors Meeting 09/20: As part of our Farm Food Safety Project, CCE Staff presented on our Catskill Farm Food Safety Project to Directors and funders from across the US. They detailed the accomplishments, objectives, and the future programming and technical assistance in Sullivan, Delaware, and Wayne County, PA. The projected is supported by a USDA grant. The grant allows CCE staff to provide technical assistance, training and workshops to farm so that they become Food Safety Modernization Act compliant, while also providing the ability to sell to wholesale institutions.

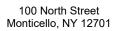

❖ We received 1,100 Senior Farmers Market Nutrition coupon booklets from NYSOFA (New York State Office for the Aging) and distributed 944 to eligible seniors. OFA staff and community partners tabled and promoted at the participating markets in Sullivan County. September 30th was the official end of distribution of the coupons.

- Nutrition continues to benefit from the Community Assistance Center (CAC)'s Food Bank of the Hudson Valley food distribution twice a month. This enables us to supplement fresh fruit, vegetables and other perishable items through our Home Delivered Meal (HDM) and Congregate program.
- Several new referrals for HDM have been received for home delivered meals. Through the initial screening process, we find many of these referrals are Medicaid clients (ineligible) or are able to go to one of our senior Nutrition sites for congregate lunch. Case workers guide them to a service that will meet their needs.
