**Reading of Public Hearing Notice Ag District #4**

Melinda Meddaugh gave a brief description of Ag District #4. She indicated that this is our Eight Year Review for Ag District #4. Over 2000 letters were sent out to landowners notifying the of the review. This is an opportunity to remove parcels from the district or to add parcels to the district. Notices were sent to the towns for their feedback. We received notification of landowners who wanted to remove parcels which are listed in the notice

At this point, Joseph Perrello joined the public hearing at 10:51AM.

Melinda Meddaugh stated there are almost 300 acres being removed. However what is viable ag land has increased based off the property codes. There is over 26,000 acres in Ag District #4 and 56% of the property is considered viable ag land. One of the properties is classified as a mining quarry operation in the Town of Fallsburg. This parcel is adjacent to a quarry but something reclassified it and we are looking into what happened. This parcel is in the Hasbrouck area (Woodbourne).

This parcel should be updated in August in the report.
