On January 17, 2023, the Citizens' Committee for Children of New York released a county-ranked study on economic security, housing, health, education, youth and community, titled *Child & Family Well-being in New York State*. **This study, relying on similar data collected for the RWJF and U.S. News county health rankings over a timespan from 2017-2020, ranks Sullivan County 54<sup>th</sup> of 62 New York counties. This information, coupled with a second consecutive annual decrease in our opioid death rate, indicates that Sullivan County, while still disadvantaged in many ways, is getting healthier!**

- We had a few COVID positive staff members in December with no direct impact to patients. There were two COVID positive residents in January and more staff members. All are fine and as of the end of January, all but two staff have returned to work.
- We are continuing hiring and recruitment efforts as always, we attended a job fair at Sullivan County as well as hired multiple new staff in the clinical departments. We have three CNAs that will be certified or recertified hopefully by mid-February. There have been multiple other hires. Current hiring focus is on clinical staff for day shift. From 11/1/2022 through present we have lost 2 clinical hires; one for health reasons and the other for attendance concerns. All others are still presently with the facility.
- Bonuses and Incentives remain in place to assist with hiring staff and for existing staff to encourage them to pick up additional shifts. We are continuing the TNA program to create more CNA's instead of attract already certified staff.
- Our annual survey ended on 1/5/2023 and we have submitted the POC. We are awaiting approval from DOH.

#### **Infection Control**

- All staff persons and visitors continue to be screened when entering the facility. This includes temperature checks, request for vaccination status from visitors, and adherence to infection control precautions for all individuals in the facility at all times.
- NYS Department of Health continues to require weekly and daily surveys sent via the Health Commerce Website.

#### **Director's Comments / Local Government Unit Update:**

#### **Care Management:**

• The care management unit continues to actively engage clients for both of the Health Home agencies and the HARP Services (Health and Recovery Plan) which are Medicaid and Medicaid Managed Care Health Plans. As of the end of December, there are five active Assisted Outpatient Treatment (AOT) orders and two people on enhanced services with one investigation.

#### Adult & Children's SPOA:

- On December 8, 2022, the Adult SPOA Committee met over the phone. Two new cases and 46 previous cases were reviewed. Children's SPOA met on December 17. Two new cases and 12 previous referrals were reviewed.
- There are 9 people on the list for Family Care. At this time, there are no openings.
- Supportive housing provided by RSS: 117 (+0) beds filled, 22 (+0) open beds, 404 (+2) waitlisted.
- Coordination of referrals and ongoing collaboration with service providers continue. Clients were recommended for/linked to various services, including: behavioral health treatment providers, RSS housing (apartment program and community residences), Access: Supported Housing, Sullivan PROS Program, OFA, APS, Action Toward Independence, Independent Living, Inc., and Care Management services.

#### **Behavioral Health Clinic (Mental Health and Substance Abuse):**

• Overdose Prevention CQI Project - The project shifted the focus from providing sustainable video-based telehealth services to opioid use disorder treatment approaches. OMH has shifted the language regarding MAT (Medication Assisted Treatment) to MOUD (Medication for Opioid Use Disorder) and also MAUD (Medication for Alcohol Use Disorder) to communicate that medication is its own form of treatment, rather than secondary role to therapy. OMH would like this to be the standard font-line approach for treating these disorders.

#### **Local Government Unit:**

- Access to Services limited due to staff shortage but doing triage for hospital discharges and court referrals predominately seeing persons for medication management., looking at overall system of care in County – United Sullivan.
- Working with our local 911 and Duchess 988 regarding collaboration and training for 911 dispatchers and referral information.
- Healing Communities Study working on the implementation of strategies supported by committee and data.

#### **Senior Community Services Coordinator:**

• Continued participation in the HEALing Communities Study as a Wave 2 Community: Phase 4 of the Communities that HEAL Intervention with ongoing planning and continued collaboration with community stakeholders.




#### **Social Services:**

- As of 12/30/22 the following amounts have been disbursed under ERAP:
  - o Rental arrears payments 707 benefits, \$ 5,507,245.82 Average payment of \$ 7,789.60
  - o Prospective rent payments- 540 benefits, \$ 1,635,947.91 Average payment of \$ 3,029.53
  - o The ERAP application closed on January 20, 2023. Applications submitted before 10/31/22 are being paid at this time.
- As of 12/30/2022, the Landlord Rental Assistance Program (LRAP) has received:
  - o 288 applications and made 186 payments, total disbursed = \$2,245,427.17
- Emergency HEAP opened on January 3<sup>rd</sup>. Regular HEAP, Heating Repair and Replacement and Clean and Tune programs are also accepting applications.
- Both warming centers in Liberty and Monticello are in operation. They have been an invaluable resource during the cold and inclement weather.
- The Temporary Assistance Unit started a Rental Supplement Program for individuals that are homeless or in fear of losing their housing. The RSP will assist in paying rent for those who have income but are below 30 % of the Area Median Income (AMI). The program will allow up to 50 % of the AMI if other criteria is met. Details can be obtained through the Department of Social Services.
  - o Received 11 applications as of 12/30/2022 and approved 7 households totaling 23 persons.



- Started 4 focus groups based on Staff in person surveys conducted Oct 2022 on topics of EMR/Documentation, Communication, Community outreach



• Healthy Families has 47 Enrolled families December 2022. FSW's have completed 75 home visits for the month out of the 91 expected. Family Assessment worker did 4 Assessments in Dec, all were assigned to different FSSs. The Assessment worker also carry's caseload of 3 families


#### **Training and Quality Improvement**

- **Preschool Program Review** A school district packet was created for 2023 new cases. The packet includes the yearly Medicaid disclosure notice and Medicaid consent forms. The packet ensures that we are compliant with Medicaid requirements. Preschool contracts sent to providers referenced our old billing provider. A meeting has been scheduled to review contract procedures and amend preschool contracts to reflect our current billing provider.
- **CHHA** Identified that the English consent forms provided to Spanish patients need to be translated. Public Health will work on an RFP in January to have all documents translated into Spanish
- **EPI** The rabies program is currently out of compliance with NYSDOH regulations; key issue is that a dedicated animal control response is required, current support from municipal animal control officers is insufficient to meet the needs of the program too many animals are not being located following suspected bites, resulting in costly vaccinations. Working with the Interim Public Health Director, Epidemiology staff, and program managers

on the Continuity of Operations Plan, which provides a framework for the continued operation of the Department of Public health mission essential functions under all threats and conditions.

#### Patient Services: Certified Home Health Agency/CHHA Census 2022

- The average daily census increased dramatically from 182.7 to 201.5 with total patient days 6248. We had 266 CHHA specific patients, 3 LTHHCP, and 37 MCH with a grand total of 306 patients on caseload throughout the month.
- For MCH- 13 total referrals (increase of 1 from Nov 22). MCH made 7 referrals to Healthy Families.
  - o 1 SCPHS RN -Pregnancy
  - 7 CPS/DFS 4 due to developmental delays;
  - o 2 WCMC 1 premature; 1 Meningitis
  - 3 Garnet- 1 Flu A; 2 NB affected by maternal substance use (NTUC- pos tox mother and baby refused care.
- The LTHHC program stayed @ 3 patients



#### **Epidemiology and Emergency Planning:**

- The Epidemiology department collaborated with CDC, NYSDOH, and Rabbi Zierler for polio education/outreach to the migrant populations and Observant Orthodox.
- A partnership with Epi and ATI was created to promote 'It's not too late to vaccinate' and SCPHS will now offer 1st/2nd and booster doses of Covid.
- Continued education re: Rabies, STI, and Immunization was a priority focus.
- Nearly 1500 cases of Influenza A were reported. 48 disease investigations took place other than STI, Rabies, TB.


