Legislators Doherty, and Salamone offer the following:

**WHEREAS,** the Sullivan County Adult Care Center is operated by the County of Sullivan under a Certificate of Need issued by the New York State Department of Health, and

**WHEREAS,** The New York State Department of Health has made certain findings upon an inspection of the Sullivan County Adult Care Center (Facility), and

**WHEREAS**, The Department's findings included an alleged violation of Article 28 of the Public Health Law (PHL) and Part 415 of Title 10 (10 NYCRR Part 415); and

**WHEREAS**, Prior to commencement of Administrative Enforcement Proceedings based upon the alleged violation by service of a Notice of Hearing and Statement of Charges, the Department and the County have engaged in Settlement Discussions, and

**WHEREAS**, The County of Sullivan has a limited and Time Sensitive opportunity to enter into a Civil Settlement with the New York State Department of Health by executing a Stipulation and agreeing to pay a 1 time fine of Ten Thousand Dollars (\$10,000.00); Now Therefore it is hereby

**RESOLVED,** That the County Manager is authorized to enter into a Stipulation and Agreemeent with the New York State Department of Health settling the alleged violations of Article 28 of the Public Health Law and Part

415 of Title 10; and it is further

**RESOLVED:** The County Manager is hereby authorized and the Legislature hereby appropriates the sum of Ten Thousand Dollars (\$10,000) to satisfy the County Obligation pursuant to said Stipulation and Settlement; and it is further

**RESOLVED,** that the County Manager and the County Attorney are hereby authorized to engage in discussions with the County's consultant at the Adult Care Center to recovery all sums paid in conjunction with this settlement.
