Commissioner's Comments:

- Child Abuse Prevention starts with each one of us. Together we can make it easier for families to access support services and learn how to identify and build on family strengths. Visit the National Child Abuse Prevention Month website for more information. <https://www.childwelfare.gov/topics/preventing/preventionmonth/>. March was an especially challenging month for our Child Protective Team with 172 separate reports investigated. This was the third highest monthly total since we started keeping records in 2007.
- Roadmap to Better Health – Updated county health rankings will be released on April 27th. Because many of the statistics tracked in the rankings lag by 2-3 years, we do not anticipate significant improvement in this year's rankings. Increasing access to substance use treatment, improving graduation rates, and fair COVID vaccination rates bode well for modest improvements in our ranking over the next few years. In the year ahead, we will adjust our focus to address what is learned from the new rankings and I expect to continue our focus on emergency mental health and substance use treatment alongside the promotion of healthier behaviors, increasing access to affordable housing, and increasing access to child care.

Infection Control/COVID Response:

- We continue to encourage all staff to get their booster, though this is no longer a requirement. Changes have been made to CMS guidance which require those who are not up to date to test based on the community transmission levels, and this is implemented at the facility.
- There are no positive cases of residents or staff in the facility as of February 28.
- All staff and visitors continue to be screened when entering the facility. This includes temperature checks.
- Survey data continues to be collected for DOH and CDC as required.

Administration & Staffing

- We continue to have several nursing vacancies. Bonuses and Incentives are in place to assist with hiring staff and to encourage existing staff to pick up additional shifts. We are piloting a TNA (aka apprentice) program to create more CNA's. One TNA is planning to test soon to certify. We continue to post positions on Indeed.com and various other websites.
- Clinical students have returned to the facility and we are also working on partnering with Sullivan BOCES as well as Workforce Development to have clinical rotations available for more students.
- The National Guard continues to provide personnel support. Support is scheduled to continue until May 31. We currently have 5 guardsmen who are trained and able to perform as a CNA would at the facility. The next rotation of personnel are expected to be certified NYS EMTs.

Community Services:

- Access to Services continues to be limited due to staff shortage but doing triage for hospital discharges and court referrals – predominately seeing persons for medication management.
- Clinic Redesign for improved access and sustainability – have prepared resolutions to enter into contract with Astor and Lexington to provide pediatric and substance use disorder services, respectively.
- 311 Call Center – RFP preparation in progress
- Drug Task Force – Treatment Pillar initiatives include maintenance of the Data Dashboard, Stigma Campaign, and development of a Narcan alert system. Significant progress made in delivering medication assisted treatment and discharge planning at Sullivan County Jail
- Processed an Affiliation Agreement and BAA with Cazenovia College for CASAC interns.

Care Management:

- The care management unit continues to actively engage clients for both Health Home agencies and the HARP Services (Health and Recovery Plan) which are Medicaid and Medicaid Managed Care Health Plans. As of the end of February 2022, there are three active AOT orders (court-ordered medication).

- As of 2/28/2022, the following amounts under the Regular Arrears Supplement program have been disbursed:
 - NYSEG, 468 benefits, \$ 938,230.42
 - O & R, 134 benefits, \$ 291,816.00
 - Central Hudson, 13 benefits, \$ 28939.44
 - Total: 615 benefits in the amount of \$ 1,258,985.80
- HEAP continues to operate most of its components. A 2nd Emergency benefit launched on 2/22/22. The Cooling component will open on 5/2/22.
- In an attempt to assist families in need of Child Care and help the economy recover from COVID-19 OCFs changed many of the Child Care Subsidy regulations effective December 1, 2021.**
 - The income guidelines for Child Care Subsidy were expanded to not only examine the 200% State Income Standard(SIS) when determining eligibility for a family but to also review the 85% State Median Income levels as well. This allows the program to serve more families.
 - OCFS changed the definition of engaged in work to now be defined as on average an applicant client must work at least 10 hours per week to be eligible for Child Care Subsidy. This is a decrease from the 20 hours previously put in place in September of 2019.
 - Child Care Subsidy cases now require to recertify every 12 months' state wide and have very specific guidelines for closing. Child Care should continue at least for a 12-month period.
 - The state is now requiring the County to cover 24 absences per state fiscal year per child per provider with no need of documentation for absence. Also the absences are covered for all types of providers.
 - The payment of family shares has been removed for Temporary Assistance, Child Preventive and Protective cases, as well as "On Behalf of the Children" cases.
 - The state also allowed Child Care Providers to apply for a Stabilization Grant. This granted allowed Child Care Providers to cover costs of personnel, rent, facility maintenance, or improvements, personal protective equipment, purchase or updates to equipment and supplies in response to COVID-19 and to aid in the health and safety of the staff and children. Out of 42 eligible providers. 39 have been approved to receive the funding from the stabilization grant.



















Housing:

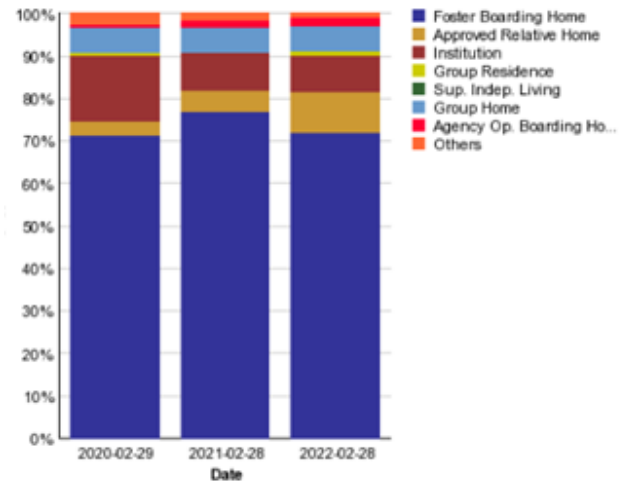
- We continue to work on the various sections of the Request for Proposal to secure Homeless Housing and Assistance Program (HHAP) funding for a Homeless Gateway Center.
- As we continue working towards the planning for the Homeless Gateway Center, staff from the Temporary Assistance Housing Unit visited the HONOR Adult and Family Shelters located in Middletown, NY to discuss their operation and tour the facilities.
- As of 2/8/2022, the following amounts have been disbursed:
 - Rental arrears payments- 388 benefits, \$ 2,911,500.58, Average payment of \$7,503.87
 - Prospective rent payments- 307 benefits, \$ 874,762.10, Average payment of \$2,849.39
- Our Housing Task Force partnership has made tremendous progress towards transitioning individuals who are homeless to permanent housing. We now have a waiting list for the supportive housing program with Catholic Charities. A year ago, there were ten open beds and now they are all full for the first time in the history of the program.
- The Emergency Housing Voucher program administered by ATI has been moving clients that are or were homeless in a hotel/motel into Section 8 housing that might not have been able to afford on a public assistance grant alone. Thus far, Sullivan County has facilitated 35 voucher applications – putting us on par with the most effective counties in the Balance of State consortium. So far, 25 vouchers have been approved and five families are now housed under the program.

Public Health Services:

- COVID Update:** We began to see a rapid in COVID-19 cases and hospitalizations to very low numbers by the end of January, which continued through February. Mandates for boosters for healthcare and public health workers were relaxed as the deadline approached and discussions at the state level regarding mask mandates in schools being lifted soon. OTC test kits and masks continue to be available and distributed to the community via ECAC and schools by the state. Vaccination clinics continued as well as planning with schools regarding testing and vaccinations although there is much less of a demand/interest.
- Discussion of impact of closure of Project Excel and outreach to determine feasibility of bringing another provider into the county to serve approximately 60 children by summer. Coordination ongoing with MCSD, BOCES, Early Care/PHS and others as needed to get another provider to provide services in Sullivan.
- The 2022-24 Community Health Assessment planning process is underway with Garnet Catskills Medical Center and will be rolled out to the broader community in March and April as we begin collecting surveys, focus groups and key informant interviews. The survey data collection will be conducted by Sienna College for the seven Hudson Valley Counties and provided to county health departments and hospitals.

Healthy Families:

- Healthy Families had 52 enrolled families in February 2022. FSW's have 95 completed home visits for the month.
- Family Assessment worker has done 3 Assessments in Feb. (The Assessment worker also carry's caseload of 4 families. The assessment worker is also training for a new procedure called "FROG- Family Resilience and Opportunities for Growth" the new Assessment tool for Healthy Families to enroll families the program.
- Program manager is also participating in the Perinatal Drug task force, pillar for Maternal Child Health issues.
- Healthy Families has received 12 referrals from Food Stamps, MA and TA consistently. We have also received a referral from local pregnancy center who are strong advocates for Healthy Families as well as the Public Health nurse. Our monthly referral numbers are increasing gradually. We have 49 screens pending assessment.
- Home Visit observations were also completed in February.

Covid-19 finally waned significantly, with new cases totaling only 540 for the month. Vaccination efforts continued with fewer persons interested in receiving vaccines. (17 clinics yielded only 215 persons vaccinated). Per diem, contract, and state staff were downsized appropriately in response. Masking regulations were relaxed.
