## Narrative of Resolution:

RESOLUTION INTRODUCED BY NADIA RAJSZ, CHAIR OF THE LEGISLATURE OF THE COUNTY OF SULLIVAN TO CORRECT THE 2024 TAX ROLL OF THE TOWN OF FORESTBURGH FOR TAX MAP #33.-1-9

WHEREAS, an application dated January 22, 2024 having been filed by Dennis R.
